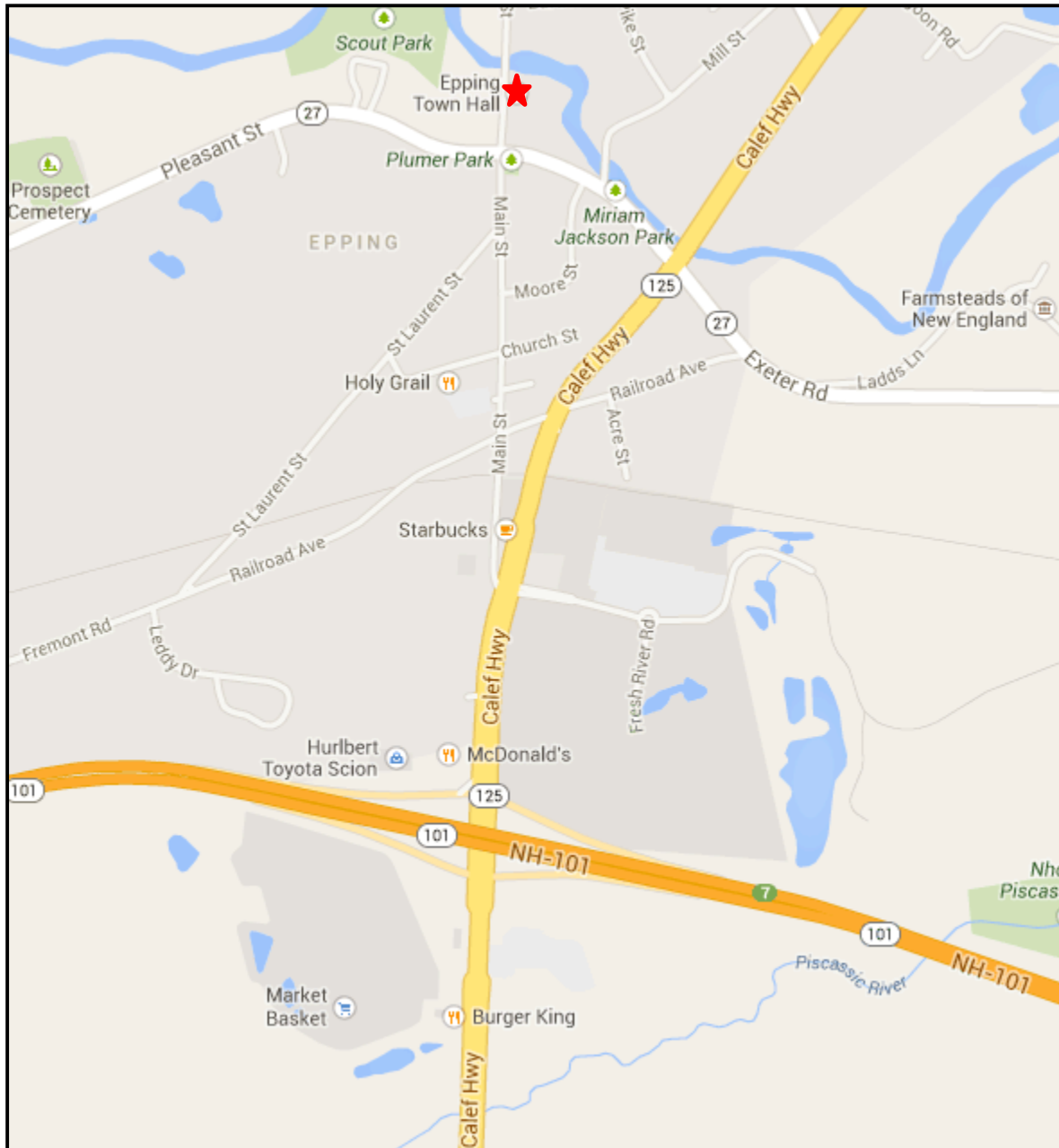

From East or West on NH 101 Proceed to Exit 7 and turn north on NH 125. At the first traffic signal north of the 101 interchange, turn left onto Main Street. Proceed to Stop sign at intersection with NH 27 (Pleasant Street) and continue straight through. Town Hall is 350 feet past the intersection on the right.
