Lafayette to Hanover is a major traffic pattern I and others use but getting to Islington to the shopping center is an issue, getting to C and I bus terminal on weekends to go into Boston to get to Airport or South station is an issue. More stops need to be added on Elwyn Road, on Court to get to the Park, to get to the Fish Market in town, to get to the end of Woodbury where the Market Basket is. I walk a lot but sometimes there is no bus stop to get me places. I hope the Portsmouth-Dover bus will hire a person to be a development officer to obtain money privately and from the federal government for transit. Seniors and teens, young adults all need transit. Also, the post office is a major problem There is no way to get to the Post office and I am a heavy user of it. This is a bit crazy. There could be a postal sub station at one of the grocery stores or in Market square. Whomever designed the survey here, I am grateful for, but that person does NOT understand barriers--I understand why this is not a criticism. But the survey doesn't at at major issues for people who must use transit. I am willing to speak to this person or the appropriate person if you choose, my cell phone is XXX-XXX and my name is XXXXXXX. I want to help in any way. But you are going to miss important information because of the way this survey is designed. Example--Uber is NOT, repeat is NOT a tool for many legally blind people who do not use smart phones. That is, you cannot CALL Uber you have to send a text which many visually impaired do not have phones that do this. Also, if you have arthritis or something else you need to use voice to call. There are many visually impaired people trying to use transit. You are not going to notice them because they don't use canes. Tis is why your survey is going to miss many, many people. My thanks for your effort and time.



A mini-city being built in Yoken's parking lot (where traffic was already congested!), another one planned on the marshes by the radio station, another one going in at Christ Church, more and more homes on Sagamore Road, and on and on......The city is creating its own traffic nightmare which will only get worse as each new pocket community it stuffs into every nook and cranny is populated. The roads and traffic lights won't be able to handle it. Already without just the above mentioned communities moving in yet, traffic is stop and go repeatedly along Roue 1 and cars are getting stuck in the middle of the intersection by the Portsmouth Hospital and U-Haul!

Fortunately, I am retired and still able to drive. I help out seniors that are no longer able to drive who need to go shopping or to the doctor or want to go to church. I feel the most important transportation issue is transporting those who cannot drive themselves for a nominal fee or for free. Being housebound due to lack of transportation is a growing need in the community.

Destinations are spread out and I am unable to walk to them (with the exception of downtown Exeter, as I live there). I cannot easily walk to a grocery store.

The roads need paving.

8 months ago

There is no public transit on the US-1 corridor from Seabrook to Portsmouth. It's my observation the US-1 gets very backed up sometimes during rush hour on weekdays, and often on weekends in the warmer months (not to mention the health effects to the local communities from tail pipe emissions). In this case, it would be very helpful to have a robust public transportation option that can get people out of their cars for their daily work commute. One of the barriers is the disdain people have about taking busses that they might not have about using light rail.

Personally, I love that the old B&M line has become a nice recreation bicycle commuting rail trail, and I'll be using it occasionally, as my health allows. That said, I think that the railroad right-of-way is quite wide enough to support a recreation trail AND a light rail transit line, though there are some engineering challenges to be overcome. One is power for the LRVs; this can be sourced from Canada, or from the Seabrook nuclear power station. Both are carbon dioxide emission free. Second, in order to have as low an impact on the trail, the line will need to be single track, with passing sidings placed at the widest points to allow frequent headways in both directions. Third, available parking at, or adjacent to, stations for people who must to drive to their local station. Of course, ample bicycle parking for those who might prefer cycling there. Fourth, a way to allow LRV passengers to take their bikes with them for use for journeys beyond the the transit line. Fifth, trail user safety; this will require demarcation separation the trail from the rail line. Hedges, a fence, or just a raised hump in between. Also, LRVs are much lighter than a conventional train and can stop very quickly if there's a person, or other obstruction on the line.

There are a lot of moving parts to this, but with sufficient planning and funding, from governmental grants, or other sources, I think this is highly doable and would be very beneficial to the seacoast region.
